CWS-CARES Demonstrates Initial Connectivity with CalSAWS

We are excited to announce that CWS-CARES has successfully demonstrated connectivity and data exchange with CalSAWS, the California Statewide Automated Welfare System. The demonstration was provided to County Constituents on Thursday, July 18.

The limited demonstration conducted in a test environment highlighted how data will move between the systems, saving time and data entry between social workers and eligibility workers. This interface will also improve data accuracy, and eventually reduce calls between CalSAWS and CWS-CARES users for information.
