Ready, Set, Test! EUST 2 Preparations Are Underway

We're gearing up for Extended User Scenario Testing (EUST) 2 activities! There are 167 staff from 30 organizations participating in this critical effort from March 24 to April 18, 2025. Staff will test CWS-CARES functions related to Case Management, Resource Management, Eligibility, and Courts. To prepare for EUST 2, testers must attend the instructor-led training sessions during the week of March 17th. During EUST 2, testers will experience CWS-CARES by executing business scenarios while providing feedback and attending optional virtual office hours for questions and support.
