EUST 2 Updates

From Classroom to CWS-CARES: The EUST 2 Training Experience

To prepare for Extended User Scenario Testing (EUST) 2, **181** county staff engaged in a twoweek training period in March 2025. Across **25** sessions, individuals in worker, supervisor, probation, and CDSS/Resource Management roles received training materials and instructor-led training. Here are some quotes from the EUST 2 virtual classroom:

Mission Accomplished: EUST 2 Yields Valuable Feedback



EUST 2 concluded with over **198** staff from **28** counties participating. This critical effort that spanned from March 24 to April 18, 2025 focused on testing business scenarios and providing feedback on key CWS-CARES functions including **Case Management, Resource Management, Eligibility**, and **Courts**. A mid-testing pulse survey yielded positive responses:

Get Ready to Explore: The CWS-CARES Sandbox

The CWS-CARES Project is announcing the future launch of our dedicated Sandbox Environment in July 2025. Up to 3500 users will have the opportunity for early access

to hands-on exploration and indepth learning as CWS-CARES evolves. The Sandbox will roll out in two phases of functionality:



Phase 1 (July 2025 - March 2026): Screening and Investigations, Case Management and Placement, Court Hearings, and Eligibility (initial determination and redetermination).

Phase 2 (April 2026 - July 2026): All Phase 1 functionality, plus Prevention Services, Case Planning, CMA, Case Management Engagement & Services, Case Closures, Structured Decision Making (SDM), Aftercare & Re-entry, Adoptions, Warrants, Jurisdiction & Disposition Hearings, Status Reviews, Other Hearings, additional Eligibility Programs, Cost Tracking, Service Delivery Tracking, Assistance Cost Tracking, Resource Family Home Management, LIS/FAS, Complaints, and Legal Action.

The Project will collaborate with counties to onboard county staff into the Sandbox incrementally beginning in July 2025. Stay tuned for more information.

Introducing the CWS-CARES Production Pilot

The CWS-CARES Production Pilot is a critical activity that involves a group of counties using the new system before the rest of the counties begin using CWS-CARES Version 1 in October 2026. The Pilot will involve 3 to 5 counties (including Probation) that will start using CWS- CARES for 4 to 6



weeks prior to the statewide rollout. This timeline will allow a smaller group of end-users to go-live early, learn lessons, identify and resolve business or system challenges, and help prepare for the statewide rollout.

> We've been encouraged by the strong interest expressed by counties who have volunteered for consideration. The selection process is a collaborative effort between the County Welfare Directors Association of California (CWDA) and the CWS-CARES Project team. Together, we are carefully evaluating the volunteers against the established criteria to select diverse pilot counties by June 2025. We look forward to sharing more updates when pilot counties are selected!
