Review of Q1 2019 Data ( <i>Kevin Kiser</i> )			<p>UC Berkeley Child Welfare Project Data</p> <ul style="list-style-type: none"> <li>- Inconsistent data entry re: date of maltreatment</li> <li>- Evaluated out instead of new referrals</li> </ul> <p>Numbers climbed when CSEC started</p> <ul style="list-style-type: none"> <li>- Now numbers trending down since changes to how CSEC referrals are opened have been implemented</li> <li>- Youth who are already identified as runaway are likely to be in another incident</li> <li>- CSEC findings stand out a lot                             <ul style="list-style-type: none"> <li>➤ Only small portion of all kids, not the whole picture</li> </ul> </li> </ul> <p>Comparison of stats</p> <ul style="list-style-type: none"> <li>- Much higher with females, Black and Latino, and older youth</li> </ul> <p>Data reflects Emergency Response Intake increasing documentation of incident occurrence dates entered into referrals</p>
