Kev Txheej Txheem:

The Adult Protective Services (APS) yog ib lub koom haum los ntawm Sacramento County Health and Human Services Department, Senior and Adult Services Division (phab pab cov neeg laus).

Ntaus Lossis /Yuam Deev

- Raug neeg ntaus, lossis raug neeg tsim txom rau lub cev yeej ua tau li ntawm cov nqaij tawv nroog thiab nqaij to mus rau txoj sia tuag.
- Raug neeg yuam deev ua phem rau lub cev yog thaum yus tsis kam lwm tus neeg los tsim txom rau yus, xws li quab yuam, ua rau yus ntshai, lossis ua tus cwj pwm phem xav ntaus neeg.

Siv Cov Khoom Txhaum Cai Los Quab

Yuam Neeg

- Cov neeg raug kev tsim txom uas mag kaw rau ib chav, lossis khi pw, lossis noj cov tshuaj. Tsuas yog ib tug kws kho mob sau tau daim ntawv tso cai siv tej yam khoom los quab yuam neeg xwb.

Kev Tsis Ntsej

- Yog thaum tus pab zov cov neeg tsis muab cov khoom ib tug neeg yuav tau siv, xws li mov, dej, kev tu cev, chaw nyob, thiab kev kho mob.

Kev Tsis Ntsej Rau Tus Kheej

- Thaum ib tug neeg laus lossis ib tug neeg laus raug neeg pab pab tsis tau nws tus kheej rau tej yam yooj yim, xws li, mov, dej, kev tu lub cev, rov mus ntsib tus kws kho mob, kev ua luam, thiab kev noj haus huv.

Ua Phem Rau Cov Nyiaj Txiag

- Nyiaj lossis siv cov nyiaj txiag rau tej yam khoom tsis zoo, credit cards, lossis cov khoom muaj tswv.
- Yuam neeg sau lawv npe rau ntaub ntawv.

Nyiaj Neeg

- Quab yuam neeg lossis tsis pub tus neeg ntawm mus qhov twg (lossis lwm yam kev ua neeg ntshai) rau ib tug neeg laus lossis ib tug neeg laus muaj neeg pab tau raug quab yuam mus rau qhov chaw tshiab.

Tso Pov Tseg

- Raug tus neeg uas lav pab tu tus neeg laus lossis tus neeg laus tau muaj neeg pab ntawv tso nws pov tseg.

Kem Cais

- Muab neeg uas tsis tsim nyog mus kaw rau lub tsev loj kuj
- Siv cov khoom tuav kom nws mus saib tsis tau cov neeg tuaj xyuas nws
- Tsis pu muab cov ntawv xa tuaj rau nws, lossis tham xov tooj, lossis tsis pub tiv tauj nws lub tsev neeg, cov phoojywg, lossis tej tug neeg txhawj txog nws.

- Pab nhriav qhov chaw tshiab
- Teem caij rau neeg xa zaub mov tuaj
- Pab nhriav cov neeg tuaj zov yus hauv tsev
- Npaj cov tshab tuaj thauj
- Kev ntsuam xyuas los ntawm lwm thawj kws kho mob
- Pab nhriav kev kho mob thiab kev kho hlwb

Tshaj Tawm?

- Ib tug tsev neeg, tug neeg nyob thaj chaw ze yus, ib tug phoojywg
- Tus neeg twg uas txhawj txog yus kev haus huv lossis yus kev kaj huv rau tus neeg laus lossis tus neeg laus tau muaj neeg pab nws.
- Cov neeg tau tshaj lus tawm

Cov Neeg Tau Tshaj Lus Tawm Muaj Li No:

- Tus neeg los pab tu cov neeg laus lossis cov neeg tau muaj neeg pab, tau nyiaj lossis pab dawb
- Cov neeg ua num kho mob
- Tus neeg ua num rau hauv cov tsev pab cov neeg sab nrau lossis cov neeg uas pab tu cov neeg laus lossis cov neeg laus uas muaj neeg pab.
- Tus neeg ua num rau lub tuam nroog tiv thaiv cov laus lossis cov tub ceev xwm nyob lub zos.

Yuav Tshaj Cov Lus Twg Tawm:

- Yog pom lossis paub txog kev phem ntaus lossis yuam deev, lossis quab yuam neeg, siv kev tsis ntsej, kev tsis ntsej rau tus kheej, ua phem rau cov nyiaj txiag, tso pov tseg, lossis kem cais
- Tshaj tawm los ntawm ib tus neeg laus lossis los ntawm tus neeg uas muaj neeg pab uas tau hais tias nws tau raug kev tsim txom lawm.
